It was on a cold day in January of 2018 that the new Emergency Room addition to the hospital in Southampton opened to take care of patients. This addition has increased the size of the building significantly.

Our community is growing rapidly and the expansion of our hospital is something that is critically needed. Work is continuing as the old Emergency Room area is rebuilt into a state of the art lab facility. Approximately 600,000 lab tests are performed each year! As well, a new gift shop for the Hospital Auxiliary along with adjoining hallways will be completed in the late fall. There have been many challenges along the way with the construction project, but as a result, our Emergency Room is state of the art and our new lab and facilities will be sure to impress.

New MRI Needed for Owen Sound Hospital

A new machine will provide better imaging, a larger range of tests, be quieter and faster to allow for shorter wait times and also be able to perform tests on larger patients. 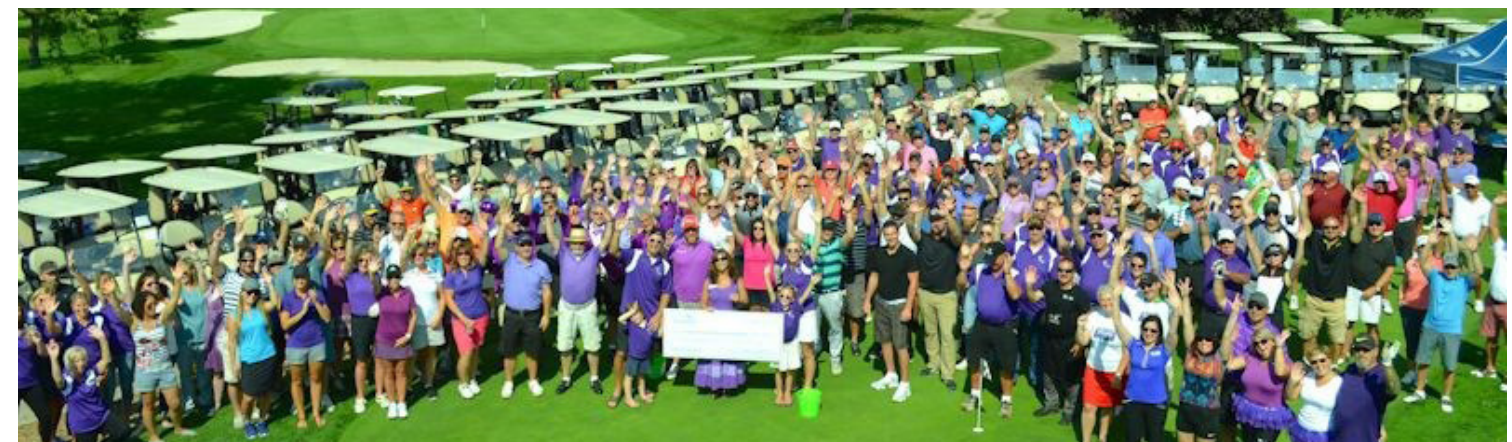
